### **Teaching-learning and Evaluation**

The vision of College is Comprehensive Development through Education along with inculcation of values and overall personality development of students from rural area. In this endeavor the college adopts the student – centric learning and experiential learning as its corner stone in academic progress of students. The college follows a transparent admission policy with first come first serve basis and follows the reservation policy of the government. Admission notifications are displayed on websites time to time and admission committee monitors the admission process.

Students are always the main focus as for as teaching learning process is concerned and are given top priority by the administration and teaching staff. The academic process run to caters the diverse need of students. The curriculum of P.A.H Solapur university is followed and the academic calendar is uploaded onto the Website and followed throughout the teaching learning process. Every Departments of the college, in addition to the adherence to the academic calendar, also maintains a separate schedule to organize its own affairs such as seminars, workshops, field trips and other academic activities.

Though lecture method is the pre-dominant teaching method, the use of ICT is integrated into the teaching-learning process and every course has its own study groups and study circles to promote participative learning. WhatsApp study groups, Google classroom, are used to involve students in a learning exercise. College has sufficient infrastructure available for ICT in the form of smart classroom, classrooms equipped with devices like multimedia Projectors & interactive board, Wi-Fi connectivity etc. Teachers have incorporated Presentations and use Google forms in their teaching and evaluation methodologies.

There is complete transparency in the internal assessment Students are given fair chance to go through their valued answer sheets, answer sheets are shown to all students and answers are also discussed in the class. In case they have any objection to raise or there is a grievance, they are given patient hearing and their issue is addressed.

The college has well qualified and highly motivated staff with 10 Ph.D. holders and 6 NET and SET qualified teachers. Regular assessment of students is carried out throughout the year with assignments, internal tests semester wise external evaluations through university examinations.

### **Research, Innovations and Extension**

The college management encourages its teachers to submit research proposals and conduct research for which a research committee has been in place to facilitate the research activities. The committee has taken the initiative to organize workshops/seminars/conferences including Research Methodology, Intellectual Property Rights (IPR) and entrepreneurship for students as well as for Teachers. Some faculty members at individual level from the Department of Geology have got research project sanctioned, which is in progress. Many teachers in the

We have functional MoUs /linkages with institutions/ industries for on the-job training, project work, student and faculty exchange and collaborative research Work.

The institution is also actively involved in extension activities to help society by its services. The college has two units of NSS through which college renders social and community services. Besides organizing blood donation camps, environmental awareness programs, road safety, Health Check-up camps, Swachh Bharat, tree plantation, awareness rallies, Gender equity and helping in disaster management.

Covid was the tough time for the world. Our many students mainly NSS students have done a great job of awareness about it and importance of Covid vaccination. College has arranged Covid Care vaccination camp in the college for students as well as for faculty members. The College has given 15 oxygen concentrator machines worth 5 lakhs to Mohol Dedicated Covid Center.

It has been used extensively during the Lockdown period. Certificate Course in Library Management is conducted by the Library Department. The library has Lib-Man Software. All books in the library are Barcoded. Lib-Man software has all the features. It can hold all kinds of reports. The library has seating for 110 readers. Various programmes are organized for the enrichment of students. Readers use regularly used OPAC. CCTV system is used for the security of the library. Various activities are carried out by the library. There are 13 Computers with Internet for the use of the students. Every year the library celebrates the birth Anniversary and Death Anniversary of Dr.S.R.Rangnathan, the father of the Library.

The Institution has a transparent mechanism for timely redressal of student grievance including sexual harassment and ragging cases. The Institution has implementation of guideline of statutory/regulatory bodies. Institution has organized yearly awareness & undertaking on policies with zero tolerance. Grievance & redressal Committees Mechanism for submission of online & offline students grievances and they timely redressal of the grievances through appropriate committees. For the support and care of female students the college has a established women development cell.

The institution has organized yearly placement Drive Camp. 29 students of outgoing placed ICICI Bank and other Corporate companies and 105 Students outgoing to PG College and University to higher education during last five year.15 students qualifying SET,NET,GATE and State Government examinations during last five years.

80 Award/Medal for outstanding performance in Sport & Cultural activities at University & State level during last five year.161 Sports and Cultural programs organized institutions and 3200 students participated during last five year.

The college has formed and registered Alumni Association. The Association named Baburao Patil Kala Va Vidnyan Mahavidyalay Mazi Vidyarthi Sansatha,Angar. The Association is formally registered at present. The constitution of the association is prepared and office bearers have been inducted as per the constitution. The regular meetings of the association are conducted and fruitful suggestions are given to the institution for overall development. The association holds saving account with Bank of Baroda, Angar Branch. The membership fees and other donations by members are deposited in the account.

Alumni provide support to provide placements to outgoing students. The alumni members who are working in

banks, teacher, Science Institute, Police & officers. guide students for preparing themselves for competitive and bank examinations. Alumni also helps in preparing students to participate in different cultural events and competitions organized at the university and other establishments. Alumni association contributed 2,65,000 for college development during last five year.

The college also publishes its annual magazine Loknete which provides a platform for their creative writing, besides publishing yearly. The institute has granted membership of students in more than 32 administrative bodies of the college such as Grievance and Redressal Committee, Anti Ragging Committee, Women Development Cell, Library Committee, Sports Committee and IQAC of the College etc.

College conducted a No vehicle day every month last Saturday to reduce the Carbon Footprint. Reduce the use of Paper in the College Office by Using Software to Make the Step towards Paperless Office. College has practiced Seed Ball Activity for the last 3 years in the Angar Village to conserve the native flora.

At our college, we strive to create an inclusive environment by hosting events such as days of eminent personalities, National Festivals, National Skills Standards, and other initiatives. These activities help to foster tolerance towards culture, region, and linguistics, as well as communal social economics. The subject of Democracy and Leadership Management has been made compulsory for all undergraduate and postgraduate students from all disciplines. Additionally, we celebrate two important national festivals annually, Republic Day and Independence Day. Baburao Patil College of arts and Science Angar is permanently affiliated to Punyashlok Ahilyadevi Holkar Solapur Univeristy, Solpaur (Previously Solpaur University, Solapur) and follows the curricula prescribed by the University. The College ensures effective curriculum delivery through a well-planned and documented process. The IQAC prepares the academic calendar of the college and also the concerned departments prepare their departmental academic calendars prior to the commencement of every academic year. The academic calendar specifies suitable available dates for significant academic and other activities. The faculty members are briefed on the academic activities of the college on the first meeting of the commencement of every academic year. The Head of the departments arranges departmental meetings to distribute and assign the workload. Considering the workload and planning held in the departmental meetings, the syllabus is disseminated as per classes and papers/courses for teaching. Thus we operationalize the curriculum within the overall framework provided by the affiliating university for that we put our resources, potential adhering to our goals. Faculty members prepare semester-wise teaching plans for theory and practical at the beginning of every term/semester. Each teacher is provided with an academic diary containing timetable, workload, Annual/Semester teaching plan, actual teaching units, daily teaching plan, and academic and administrative committee responsibilities. The academic diary is monitored by the concerned Head of Department and the Principal of the college. The timetable committee prepares a general time-table and HoDs of concerned departments prepare departmental timetable. Teachers conduct classes according to the timetable. IQAC and departmental meetings are held periodically to review the syllabus completion. For the effective transmission and delivery of curricula, departments integrate classroom teaching with various ICT tools, laboratory practical, field projects, students seminars, tutorials, question papers solving, research projects, field survey, on-the-job training etc. For the upgradation of subject-related knowledge, college organizes seminars, conferences, and workshops. This activity provides a platform to the faculty and the students to participate and interact with experts in various fields and enrich and update their subject knowledge. For the effective curriculum delivery, teachers use participative, problem solving and student-centric learning methods. Faculties effectively and creatively use PPTs, video lectures, models, charts, various educational softwares for delivering the subject knowledge. The college organizes guest lectures, expert lectures of eminent academicians for the effective curriculum delivery. College also provides special guidance to the slow learners under the Special Guidance Scheme and remedial coaching etc. Besides this, the college has a mentoring system for academic-related issues. Library provides INFLIBNET, e-journals, Database, Shodhganga, OPEC, Book Bank facility etc. The college also provides internet connectivity with the campus Wi-Fi facility to the students and the teachers for effective teaching-learning. Teachers provide study material and distribute it to the students. IQAC periodically conducts the Academic and Administrative Audit by the internal peer for further improvement in the academic and administrative activities. At the end of every academic year, IQAC

collects feedback on curricula from all the stakeholders.

**Response:**

The college conducts various student centric activities throughout the year. The learning becomes more experiential, participatory by organizing activities like group discussions, field visits, assignments, seminars, project writing, exhibitions, publication of wallpapers, writing articles, poetry recitation and power point presentation. The college organizes co-curricular activities, extra-curricular activities, sports and cultural events which help the students for their all-round personality developments.

Practical based knowledge are offered to the students through language labs and science labs where learning is acquired through demonstrations. Students verify the facts and laws of the subject with the help of experiments. Especially, the department of Chemistry, Physics, Botany, Zoology and Geography uses this method. Students take interest and learn things via experiential learning.

Departments of college organize excursion tours, field visits and industrial visits at various places so that students become aware of applied aspect chemistry. In excursion tours students observe the beauty of nature, importance of the conservation of endangered plants and understand the ecological significance by observing and analyzing. The students submit the project report on their experience.

Department of Chemistry organize college level 'Avishkar' festival each year . The students carry out research projects and present their research through power presentation. Each year faculty follow participating in teaching-learning process through questions– answers method, group discussions, Quiz, brainstorming sessions and students? seminar on different small topics.

Department of Botany organized 'Ranbhaji mahostav' in which students prepare traditional culinary using local wild vegetables in this effort student get aware of botanical names of plants, nutritional value of vegetables along with various uses of plants. Along with this the effort also give boost to creativity among students. Department of botany organize fruit and salad decoration event so that students get aware of technique of flower arrangement and nutritional values of fruits and vegetables.

The department of Marathi organize poet recitation competitions and poster competitions to boost communicational skill, public speaking skills, creativity among students. It also boost emotional and philosophical thinking among students.

The college has annual publication (college annual) called " Loknete", Students are assigned to work on the editorial board of college magazine which improves their creative and administrative skills.

Student work on small projects of students to develop research aptitude among students and to enrich the practical knowledge among students.

To inculcate patriotic and social values among students various Days like Teachers Day, Independence Day, Republic Day, NSS Day, and Anniversaries of national heroes are celebrated blood Donation Camps, AIDS Awareness Campaigns, Tree Plantation, De-addiction Drives, Swachh Bharat Abhiyan.

## 2.5 Evaluation Process and Reforms

### 2.5.1

**Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient**

**Response:**

At the college level, an examination committee is constituted, comprising of a senior Faculty member other teaching faculty as members for smooth conduction of end semester examination. The end semester examination is conducted by university, and the students appear at center allotted by the university.

**The evaluation of each course shall contain two parts:**

**Internal Assessment (IA) and End-Semester Assessment university assessment**

The institute follows 70:30 pattern of evaluation were 30% evaluation is done by institute through internal examination which is carried out by various ways like Home assignments, internal examinations, which may be long answer on through Home assignments, objective type questions or objective test on online platform through Google form and Google classroom. Assignments questions are discussed with students. The schedules of internal assessments are communicated to students and faculty at the beginning of the semester through institute academic calendar which is prepared based on the university academic calendar.

The internal exam time table is displayed on the notice board a week in advance. Faculty sets

questions from each unit covering all topics. Respective faculty prepares the answer key and scheme of

valuation of the internal assessment paper. Internal assessment questions are set by allotting equal weightage from all the units for the intended syllabus.

Students are counselled by their mentors so as to encourage them to perform better. Nearly 25 students are entrusted to each faculty member to be mentors and advisors of the students. The mentors sort out the personal issues, academic and non-academic problems of their mentees and provide counselling and guidance.

Practical Examination: Evaluation is done with transparency based on different parameters like Teachers Assessment, Practical Records, Performance and Viva-Voce.

For undergraduate students, internal assessment comprises term end examinations and practicals or assignments. Practical are conducted regularly and according to a well-planned and properly communicated schedule. All prescribed practicals in syllabus are conducted and the students are given sufficient hands on practicals carrying them out. Thus, students are prepared to perform well in the practical examinations. Term-end examinations are held at the end of the first term. Term-wise syllabus as prescribed by the affiliating university, is completed in each term. The internal examinations are conducted following the same model as the final examinations. The college internal assessment simultaneously across all streams to maintain uniformity and transparency. Every teacher maintain the record of submissions evaluation as per university norms. The student can approach to concerned teacher to clarify related grievances as per his/her requirement.

For External Examination the evaluation work is done by the university. After result declaration, students who are not satisfied with their marks can demand for photocopy of their related subject answer sheet. The student can apply for Rechecking/ Revaluation by filling up the Rechecking/ Revaluation forms by paying the university fees within given tentative dates after declaration of result.

## 2.6 Student Performance and Learning Outcomes

### 2.6.1

*Programme Outcomes (POs) and Course Outcomes (COs) for all Programmes offered by the institution are stated and displayed on website*

#### Response:

Our College is affiliated to Punyashlok Ahilyadevi Holkar Solapur University. We offer Under Graduate

under the Faculty of Arts and Science. For these programs and courses, the institute followed the curriculum designed by our affiliated university. The copies of the syllabi are kept in the department. write among students. However, the student can download the syllabus from the website of Punyashlok Ahilyadevi Holkar Solapur University. The programme outcomes, programme specific outcomes and course outcomes are evaluated by the institution and the same are communicated to the students in the formal way of the discussion in the classroom and departmental notice board. Further, the faculty of every subject explains the course objectives, evaluation pattern, marking scheme etc. to the students. It is also given in the syllabus of each subject. The students' are evaluated according to their ability to remember and understand are tested through Multiple Choice Questions, Short Answer Questions, Quiz, Oral Test, whereas their ability to apply, analyse, evaluate and create are assessed through Essay Type Questions, Assignments, Practical Examinations, Field Report.

After measuring attainment of POs, PSOs and COs, it has been observed that the strength of the students as well as passing percentage of the students is increasing progressively. Besides, students' progression to the higher studies that is from Under Graduate to Post Graduate seems to be increasing consistently and rapidly in the last five years. In a similar way, the ratio of students placement is also increasing with arrangement of placement drives in college campus. We took utmost care of measuring the level of attainment of POs, PSOs and COs and followed formal as well as informal mechanism for the measurement of attainment of the outcomes. Even we took feedback from all the stakeholders like students, alumni, parents, teachers, employers about curriculum in this respect and try to take necessary steps accordingly.

Student's knowledge and skills are measured directly from their performance in the class/assignment test, internal assessment tests, assignments, semester examinations, seminars, laboratory assignments/practical, mini projects etc..

Subsequently, the College took care of the attainment to measure the POs, PSOs and Cos and implemented the mechanism as follows:-

- The institute followed the Academic Calendar of our affiliated university along with this college follows its own academic calendar.
- Internal examination committee analyzed evaluation reports of results.
- Institute considered Feedback from the Stakeholders for the attainment of PO, PSO and CO.
- Placement committee took the review of the Students Progression to Higher Studies and their Placement.

Attainments of CO's are calculated by using university examination results. Attainment levels are finalized at college level and conveyed to IQAC through Internal Examination Committee. The attainment level of each CO is computed by setting weights as follows:

The levels of accomplishing the outcomes of each course are considered to be point 4 for substantial, 3 for good, 2 for moderate and 1 for low. The assessment is done from the responses given by the students using the following formula. CO indirect attainment =  $(4*A+3*B+2*C+1*D)/(4*(A+B+C+D))$  where A, B, C, and D are the number of students choosing substantial, good, moderate and low options for the corresponding CO.

Set in the extensive green cover, the college has an aesthetic landscape.

The institution has a well maintained, user friendly infrastructure conducive to teaching, learning and comprehensive development of students. The Teaching Block has well-appointed and spacious classrooms, department rooms and well-furnished laboratories. The classrooms are equipped with projectors. One smart classroom is available for conducting power point presentation and online video lectures. There are two computer labs available for the students. These labs have adequate computer equipment, internet connectivity and projectors to support practical sessions. College has Wi – fi facility for whole campus for the benefit of students and faculty.

The well-stocked College Library is spacious with reading section, Online Public Access Catalogue, Processing Section, and Stacks. Library has e resource, e-journals through INFLIBNET and N-LIST, Reference Section, Book Bank. The Administrative Block of the college consists of the Principal's Office, the Accounts Office, and the IQAC Office which is fully ICT enabled. The Multi-Purpose cultural Hall is suitable for Academic events like conferences, seminars, talks etc. and cultural equipment's for student activities. The facility can be used to record lectures and create e-content.

Separate rooms for NSS, Placement & Career Guidance and also for counselling cell. A separate room with adequate infrastructure and space is allocated for IQAC so as to coordinate and monitor various academic and non-academic activities of the institution. **Network and Wi-Fi:** The old VPN internet connections are replaced with high speed optical fibre broadband connections. The college has built campus network with optical fibre nodes. The campus of the college has Wi-Fi facility with a speed up to 10 Mbps.

The college has well-equipped, high-configuration computers with back up facility. Students are permitted to access the internet facility through computer labs and departments. College has 01 smart classrooms, 02 classrooms are with ICT- enabled facilities such as LCD projector, Wi-Fi, LAN etc. During pandemic situation, classes were conducted on-line using zoom and for students across all streams.

Library has web- OPAC. The Library provides Internet facility for students. All electronic resources subscribed under N-LIST Programme are available for faculty members.

A mechanism has been established to expand the wired network as needed. Wi-Fi zones have also been established on campus. QR codes are pasted inside classes to access wi-fi for students. All academic departments, administrative buildings, canteens provide Wi-Fi zones. Important areas on campus are monitored by IP cameras.

College has developed web-based ERP (Enterprise resource planning) software used for admission and administrative functions. For IT software, hardware repair and upgrading done by annual maintenance contract. Private agencies are also hired as per necessity.

The college has installed wide surveillance system with 80 CCTV cameras mounted at prime locations as classrooms, laboratories, office, library, gymnasium, corridor, parking lot etc

The college has five prime computer laboratories built up with LAN and Wi-Fi facilities; along with it computer facilities are also available in Chemistry department. The college has total computers with 01 laptops having latest operating systems (as window 11, windows 10, Linux) and updated antivirus and

software.

The college has made Wi-Fi enabled using 22 Routers from BSNL telecommunication.

College purchases computers, laptops and other IT equipments annually as per the students enrolment ratio.

## 7.2 Best Practices

### 7.2.1

**Describe two best practices successfully implemented by the Institution as per NAAC format provided in the Manual**

**Response:**

**Title of the Practice: Seed Ball Activity**

**Objectives of the Practice:**

1. College IQAC, NSS and Department of Botany decided to run seed ball activity.
2. In this activity the college students are going to collect germ plasm (seeds) of native plants, dry them and use them for the seed ball activity.
3. The village Angar has forest land and barren pastureland near Kurunwadi. It is then decided to this activity at Kurunwadi. Kurunwadi is located at Latitude 17.86720N and Longitude 75.58010E of village Angar.
4. IQAC, NSS and Department of Botany decided to this activity for every year and take follow up of the selected area after every 5 years.

**The Context:**

Seed balls are small bundles of seeds, clay, and soil or compost. Although seed balls have been around since ancient times, they were rediscovered in the 1930s by the Guerilla Gardening movement as a way to covertly introduce vegetation by simply tossing the seed balls (or, on a large scale, dropping them from an airplane). They are still used today to revegetate areas burned by wildfires. On a small scale, seed balls are fun to make and offer an inexpensive way to sow native plants and flower.

Above germ plasms were collected from forest near Angar village, Nannaj Bird Sanctuary,

Nannaj and Siddheshwar Forest, Solapur. The germ plasms (seeds) of these plants is collected by students and teachers and brought to the Department of Botany laboratory. Here the seeds are thoroughly examined, dried, and stored.

## **The Practice:**

### **What is Seed Ball?**

Seed balls are small bundles of seeds, clay, and soil or compost. Although seed balls have been around since ancient times, they were rediscovered in the 1930s by the Guerilla Gardening movement as a way to covertly introduce vegetation by simply tossing the seed balls (or, on a large scale, dropping them from an airplane). They are still used today to re-vegetate areas burned by wildfires. On a small scale, seed balls are fun to make and offer an inexpensive way to sow native plants and flower.

### **Procedure to make Seed Balls:**

1. Moisten clay. Mix clay with water until it is the consistency of yogurt or softserve ice cream.
2. Mix with sifted compost in a 1:1 ratio clay: compost by volume. Cut the clay into the compost like creaming butter and sugar together, then wedge it like clay or dough.
3. Add water so that the matrix is workable enough to make balls hold together, but not sticky. If it is too sticky, mix in some sifted compost until you have the right consistency.
4. Pinch a seed-ball's worth of matrix off of your prepared clump.
5. Add some seeds. If they are easy germinators, 1-2. If they are stubborn, add some more. You do not want 8 germinating seeds in one seed ball. That will stress the seedlings, and none will thrive.
6. Roll into a ball.
7. Air dry at room temperature until the batch is uniformly light color.

### **Evidence of Success:**

Evidence of Success: Since the activity has begun from this year itself evidence of success yet to be discovered.

### **Problems Encountered and Resources required:**

1. Germplasm / Seed Collection
2. Soil
3. Farm manure
4. Rainfed or rain shadow area due to which percentage of germination and survival is minimized
5. Cattel Grazing area due to which percentage of germination and survival is minimized

**The Practice:**

1. To initiate the activity, the college office first gathered the data of presently admitted students and distributed among the staff.
2. To each staff the 20 students were allotted. The staff member is designated as Mentor while the 20 students allotted to him/her are considered as Ward .

2. The practice was huge success for getting the government scholarships to the students. As the college was not opened during the pandemic situation the way of communication was limited. In such situation this practice helped the student to overcome the problem to get their scholarships.

3. College has organized the webinar series on Covid vaccination so that majority of the students will get aware regarding Covid 19 vaccination.

4. During the pandemic many of our students lost their parents, which is a huge loss for them. In such condition due to this activity student get benefit of moral support. To motivate them college management had started the “**Loknete Baburao Patil Niradhar Vidyarthi Shishyvrutti**

**Yojana**”; under which total 08 students (4 Girls, 4 Boys) were benefited.

**Problems Encountered and Resources required:**

3. During the practice it is noted that Girl students do not possess smartphones with them; due to which conveying of the notices, messages was a real problem
